**Topic:** Purchase Approval - Avkin Wearable Simulators

**Presentation:**

In the College's health clinical areas, the use of simulators assists students to maximize clinical experiences and mimic real-life work within the field. The College has been awarded approximately \$488,000 in state funding through the Pipeline for the Advancement of the Healthcare Workforce Program (PATH). As part of the grant's budget and outcomes, the Nursing Program is seeking to expand its simulation training. After researching several pieces of technology, program leadership has identified the Avkin Avcath Mid Tone simulator and the Avcath Light Tone as the best value and instructional tool for the department's needs. Contracts for integrated software and equipment are exempt from publicly solicited bids under the Public Community College Act (110 ILCS 805/3-27.1) and SVCC Board Policy 305.01.

**Recommendation:**

The administration recommends the Board approve the purchase of the Avkin Wearable Simulators in the amount of \$44,920.00 to be paid from the PATH Grant funds.
