Presentation:

The administration has been in the process of hiring a Director of Admissions and Academic Advising. The position was advertised on-line on Sauk Valley Community College's website, *Indeed.com*, Chronicle of Higher Education, *HigherEdJobs.com*, and in Sauk Valley Media (the *Dixon Telegraph* and the *Daily Gazette*).
