- ¹ Minimum 1.5 times the highest in-district tuition rate of any neighboring contiguous Illinois community college districts.
- ² Minimum of 1.67 times its in-district tuition rate.
- 3 ICCB Administrative Rules allow for an exclusion of out-of-district and out-of-State rates for online courses.
- ⁴ Overall program charge per student is set at \$5,150 for 12 credit hour program per agreement with third-party provider.
- ⁵ This fee is assessed per student and course are charged directly to high schools participating in the College's dual credit program where the courses are taught at the high school by a high school instructor. There is no proposed change to the waivers applied dual credit courses offered by the College or taught at the high schools by College instructors.
- ⁶ This fee is new for academic year 2023-24 and is assessed per course enrollment (not per credit hour) to provide student access to a specialized learning management system (LMS) integrated with course instruction that was previously obtained by students through a third-party. This fee applies to ELT 120 HY, IND 118 HY, IND 218 HY, ELT 262 HY, and ENE 130 HY. Students enrolled in multiple courses will have \$120 waived for subsequent enrollments in a given term.

Tuition Pricing Philosophy

Designed to provide an accessible and affordable education to Sauk Valley Community College students with a focus on transparency and fairness.

- One universal tuition rate
- One universal student fee
- Course fees that fund instructional activities specific to departmental expenditures based on average annual departmental expenditures
- Sufficient tuition and fees to maintain and/or improve levels of student service
- Market appropriate tuition and fees
- No limit on amount generated from tuition and fees as a percentage of total operating revenues
- Modest incremental increases in tuition rates (slow and steady approach)
- In-district rates for online students
