**Presentation:**

With SVCC's "Jerry Mathis" Theater being heavily used for instruction, conferences, group presentations, and as a community theater, this area's technology has hit its end of life and needs replacement. In order to meet the needs of our end users, the College needs to purchase the following technologies: laser projector, projector screen, PTZ camera, microphones, iPad, audio mixer, audio amplifier, and networking/control systems at a total cost (including installation, setup, and programming) of \$39,797.97.

Illinois Public Community College Act (110 ILCS 805) and SVCC Board Purchasing Policy (305.01) exempt contracts for the purchase and installation of IT equipment from public bid/solicitation requirements.

The equipment will be purchased from Conference Technologies, Inc, CDWG, B&H Photo, and Amazon with consortium and Education discounts applied. Additionally, Conference Technologies will install, setup, and program the technology.

**Recommendation:**

The administration recommends the Board approve the purchase of laser projector, projector screen, PTZ camera, microphones, iPad, audio mixer, audio amplifier, and networking/control systems from Conference Technologies, Inc, CDWG, B&H Photo, and Amazon for \$39,797.97 to be paid from restricted use bond proceeds.

## Video

The video system will be upgraded and replaced to provide industry-current connectivity and improved quality. A new projector will be installed and will be fed from a new video switcher in the existing rack. In conjunction with the update, the VGA plate will be removed from the stage, the wiring will be replaced, and (2) HDMI extender plates with 3.5mm audio will be installed in its place. These two sources, along with a connection for a rack PC/Laptop will be available on the aforementioned new switcher. Additionally, (2) new PTZ cameras will be installed, one for the front of the Auditorium (20x zoom camera mounted above the projector) and one for the crowd (12x zoom camera mounted at the front of the auditorium, house-left, above the stage), and will be available via USB connection for UC soft codec applications (i.e. Zoom) to the rack PC. Finally, a new motorized screen will be installed to replace the existing one.

## Audio

(4) new wireless mics, two handheld and two over-ear, will be installed and will replace any existing wireless mics. Additionally, a new DSP will be installed in the AV half rack to replace the small mixer currently in said rack. The DSP will receive the wireless mic audio, the video program audio, and the (2) 3.5mm audio feeds from the stage and will output its mix to either the OFE amps or the OFE mixer, depending on client preference. Additionally, USB audio for UC soft codec applications (i.e. Zoom) will be available through this DSP to the rack PC.

## Control

The DSP/Processor, mentioned above, will also provide control for the space, making the room operation easier to use for both experienced and inexperienced users. It will allow the user to turn the system on and off, control projector power, send the motorized screen up and down, adjust the wireless mic, program audio, USB audio, and stage 3.5mm audio levels, and select the system video input. The control interface will be an iPad and will be useable from anywhere within range of the new wireless access point installed on the system's closed LAN. The iPad will come with a case and a tabletop stand so it can both be held or can sit on top of the rack or in the booth.

## Equipment Location

The old equipment will be removed from the AV half rack, in the Auditorium proper, and all new equipment will go in said rack. The new projector and new screen will be installed in the same locations as the existing equipment.

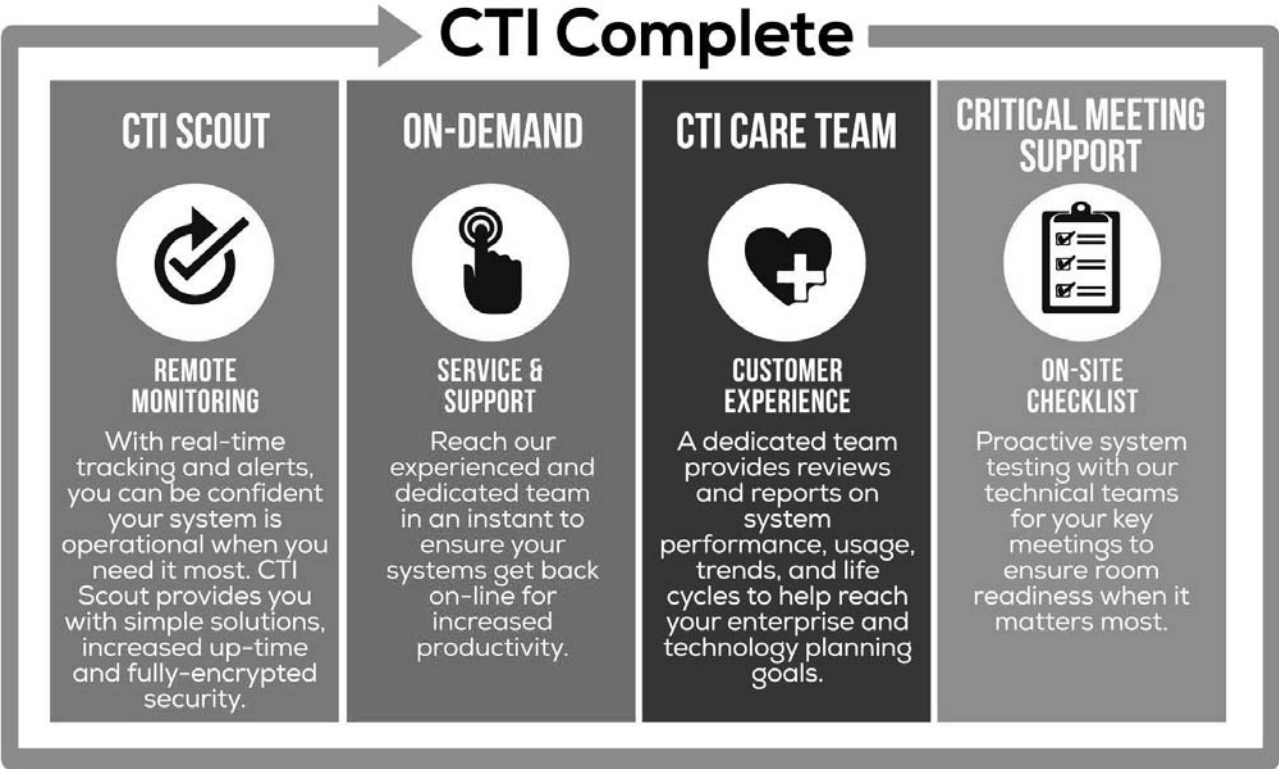
